

**Important Information Regarding Drop For Non-Payment (DNP)**

After a pause in the enforcement of **Drop for Non-Payment (DNP)**, SDCCCD will resume the state directive of collecting enrollment fees in Summer 2021.

**If Summer class enrollment fees are NOT paid by the two drop deadlines (5/22 and 6/5), the unpaid class(es) will be dropped the next day.**

No Payment or Enrollment activity (Such as ADD, DROP, SWAP, EDIT) will be allowed in Campus Solutions for Students or Staff while the DNP process is running on the two Sundays: May 23, June 6 (From about Midnight to about 3pm)

Students who belong to one of the following protected groups **will not be dropped:**

- Only owing the Health and Insurance fees
- On a Payment Plan for this semester
- With Anticipated Financial Aid (incl. CCPG)
- Veterans with Anticipated Aid (Chap 31, 33)
- With an R2T4 indicator
- Officially enrolled in the SDCCCD Promise Grant program
- In an Apprenticeship program
- Concurrent High School Students
